1. Does the Executive Committee of the ISSF appoint the Jury Members for every ISSF Championship		
2. Backing Targets, Backing Cards and Control Sheets must not be patched or changed until after scoring is completed.		
3. In 10 m & 50 m events, unlimited sighting shots may be fired before the first competition shot.		
4. Independent of the results determination, the Classification Jury must examine the best 10 individual and the best 3 team results.		
5. If a pistol fails the Random Trigger Weight control check three times after the Qualification phase of the 25m Pistol Women event, she must be disqualified		
6. If an item of shooting clothing fails after re-check, what is the waiting time, to check it again, and how many times the items can be retested.		
7. The ISSF Juries and Organising Committees are responsible for safety.		
8. When using Electronic Scoring Targets, the athlete must not obscure his monitor screen.		
9. Athletes are encouraged to bring any items of equipment to the Equipment Control Section for checking if they are not certain if they will pass a post-competition check.		
10. Athletes may smoke between shots.		
11. Electronic Scoring Target Technical Officers must not take any decisions.		
12. The pistol must be held and fired with one hand only.		
13. How many shooting jackets and shooting trousers are allowed to be used during one competition?		
14. If an athlete fires a shot accidentally before the command "LOAD" he must be disqualified.

15. Decisions by the Classification Jury on the value or number of shots on a target are final and may not be appealed.	
16. Inside pockets are allowed in a shooting jacket.	
17. Electronic triggers are permitted, providing certain conditions are met.	
18. In all 25 m events, the pistol must not be loaded with more than five cartridges.	
19. When the pistol is out of its case, it must always be pointed in a safe direction.	
20. Pre-Event Training. The range must be available for a minimum of one hour on the day before the event.	
21. For 25m Paper Targets, plug gauges will be inserted by the Chairman, of the Jury, if necessary.	
22. Official Protests. A Protest Fee of US\$50.00 is payable for all protests.	
23. Athletes and Team Officials must be informed of the exact shooting time schedules no later than 12.00 hours on the day preceding the competition.	
24. Individual Scores. All scores will be broken for ties after the Qualification stage, except for perfect scores.	
25. An athlete may wear a shooting hat or head band that has a manufacturer's logo on the front.	
26. 25 m Rapid Fire Pistol Men. Before the beginning of each stage, the athlete may fire one sighting series of five shots in 8, 6 or 4 seconds as requested by him.	
27. 25 m Rapid Fire Pistol Men. If there is a tie to be eligible for the Finals, the tie will be broken by a shoot-off.	
28. Will an athlete be disqualified if they do not have an ISSF ID number?	
29. Outward Scoring Gauges are used to determine inner tens on the 10m Air Pistol Target.	
30. In 25 m Rapid Fire stages, the athlete must not rest his pistol on the bench, or shooting table, during the series.	
31. The Chief Range Officer is responsible for assuring the co- operation of all Range Personnel with the Jury.	
32. The decision of the Jury of Appeal is final.	



33. Finals' athletes must report to the Preparation Area at least 30 minutes before the scheduled starting time.	
34. The repositioning of wind flags is permitted only for the 50m events.	
35. English is the permanent official Language.	
36. If an athlete handles a gun in a dangerous manner he may be disqualified by the Jury.	
37. Malfunctions during RFP Finals. In the case of a NON- ALLOWABLE Malfunction, 2 hit penalty will apply.	
38. Telescopes or binoculars are permitted to be used by athletes for 10m Air Pistol events.	
39. If all the targets on a range fail, the expired shooting time must be recorded by the Chief Range Officer and the Jury.	
40. When not actually firing, all pistols must be unloaded and safety flags inserted.	
41. Finals Preparation Time for 10 m rifle and pistol, 50 m Pistol and 50 m Prone Rifle Event is 10 minutes.	
42. During a competition a loaded pistol may be put down providing it is pointing to the target area.	
43. In 25 m events, if the shooting is interrupted for technical reasons for more than 5 minutes, the Jury must allow an extra sighting series	
44. Athletes from the same nation should not be allocated adjacent firing points.	
45. Any Elimination should be the day prior to the scheduled Qualification.	
46. If an athlete boxes his pistol without having it checked by a Range Officer, he may be disqualified.	
47. The shooting underclothing must follow ISSF rules, or is it not specified.	
48. The diameter of the inner ten on the 50m Pistol target is 12.5 mm.	
49. Athletes may not wear sandals of any type or remove their shoes (with or without socks).	
50. If an athlete arrives late, through his own fault, he may participate but will not be granted any extra time.	
51. Any shot fired accidentally after the command "LOAD" but before the beginning of a competition series, must not be counted and will incur a penalty of 2 points.
