Khelo India is a flagship program of Government of India for promotion of sports & achieving excellence. Under State Level Khelo India Centres (SLKIC) vertical of Khelo India, it is proposed to support better utilisation of sports infrastructure through a suitable MoU with eligible agencies and to provide financial support for engagement of coaches and support staff, day boarding/ residential facilities, regular maintenance of playfields, sports equipment (consumable & non-consumable), etc. for nurturing of talent through usage of existing sports facilities available with these agencies. 
