CIRCULAR FOR CONDUCT OF OLYMPIC SELECTION TRIALS

It has been decided to conduct two sets of Olympic Selection Trials (OST) under Rule 4 of Criteria For the Selection of Olympic Shooting Team. The Criteria is available on website www.thenrai.in. The dates and venue of OSTs are as under:

OST 1 & 2 Dr. Karni Singh Shooting Ranges, New Delhi April 18 – 27, 2024 OST 3 & 4 M P Shooting Academy Ranges, Bhopal May 10 – 19, 2024

The NRAI will ensure that trials are conducted in all fairness, transparent, and adherence to regulatory standards during Olympic Selection Trials.

- 1. Participation in selection trials is restricted to shooters who fulfil the criteria as stated under Criteria For the Selection of Olympic Shooting Team. Event wise list of shooters is attached herewith.
- 2. Shooter will participate in events in which they are eligible. Multiple participation in events is not permitted, if not qualified.
- 3. All participants of OST must submit an undertaking affirming their knowledge and understanding of ISSF Rules, NRAI Match Book, NRAI Selection Criteria, and NADA/WADA Rules. The format of the undertaking is attached separately.
- 4. There is no entry fee for participation in OST.
- 5. Trials will be conducted in accordance with ISSF Rules.
- 6. Matches/Finals will be conducted as per format of 2024 Olympic Games, Paris.
- 7. No request for any adjustment shall be entertained and shooters are required to shoot their matches on date and time in accordance with notified schedule. Copy of the schedule is attached herewith.
- 8. Juries and range officials, will be nominated in accordance with ISSF Rules.
- 9. No one other than the NRAI officials will be allowed to enter Field of Play (FOP). Parents/personal coaches will not be allowed to sit behind shooters during the conduct of Finals. All may sit in the spectator area.
- 10. Since a small number of shooters are participating in each event, no ammunition will be provided at ranges. Shooters desirous of purchasing the ammunition, may visit NRAI office to collect ammunition.

- 11. Shooters will have to make their own arrangements for boarding/lodging and transport for participation in OST.
- 12. NADA team is being informed about trials and it may collect samples, as per their norms.
- 13. The NRAI reserves the right to amend the rules/schedule at any time at its sole discretion for events/circumstances beyond its control. Any decision made by the NRAI in any such matter will be final. All participants are expected to abide by the rules and regulations for the competitions. Discipline on and off the field is very essential.
