## ALL AFFILIATED UNITS OF NRAI ALL MEMBERS OF GOVERNING BODY OF NRAI

## Dear Sir/Madam

The Governing Body in its meeting held on 23<sup>rd</sup> July 2016 has accorded its approval for the conduct of domestic competitions in Rifle/Pistol events in India by the affiliated units of NRAI. The Rules for the conduct of domestic Shooting events were approved as under:

- a. These competitions shall be conducted by affiliated units of NRAI with prior approval of NRAI and shall be conducted under the direct supervision of NRAI.
- b. Only one competition per quarter shall be permitted. The affiliated units intend to organize these competitions must apply to NRAI before October every year so that these competitions are included in shooting calendar of subsequent year.
- c. The technical conduct of the competition shall be under the control of the NRAI.
- d. These competitions shall be conducted only at ranges equipped with SIUS ASCOR SYSTEM.
- e. Original consumables of SIUS ASCOR shall be used during the competitions.
- f. The other terms and conditions are as under:
  - i. The competition will only be conducted under ISSF rules.
  - ii. The events will be conducted in seniors and junior category. Youth events will be conducted only in Air weapon events.
  - iii. The level of these competitions is categorized as "All India".
  - Shooters who have achieved MQS under rule 17.6 of NRAI Match Book during the current or preceding NSCC shall only be allowed to participate in these competitions.
  - v. No wild card for participation in these competitions will be awarded.
  - vi. No other competition, whatsoever, will be conducted concurrently along with these competitions.
  - vii. No National Rule matches will be conducted during these competitions and scores of these competitions shall not be considered as qualifying score for the next NSCC.
  - viii. The NRAI shall nominate all technical officials for the conduct of these competitions as per ISSF rules and all expenses towards their travelling/boarding/lodging shall be borne by the Organizers.
  - ix. Scores of these competitions will be considered for calculating the average for selection of teams for National Squad/international teams.
  - Entries will be received by NRAI and after checking the entries, shooters will be allowed to participate in these competitions.
  - Team events may be conducted and every State is permitted to field a maximum of two team per event.
  - xii. NRAI shall deduct 30% from the total entry fee collected on revenue sharing basis.
