Sub: North East Zone NRAI National Coaches Course (Rifle & Pistol)

Dear Sir/Madam,

It gives me great pleasure to share with you that NRAI, has a new Coaches Course to upskill and update the knowledge of Indian Coaches. The NRAI has decided to introduce its own Coaches Education Program including Course design and material to address the developments in shooting sport and to equip our national coaches with the correct tools.

The program will be conducted in two parts, and the **first part of the program will be held from 24**th **to 30**th **April 2024 at Assam Shooting Range, Kahilipara, Guwahati, Assam** under the aegis of the National Rifle Association of India. The second part dates will be announced in due course of time. The instructors nominated by NRAI shall conduct this Course.

As a commitment by NRAI towards promoting, the sport of shooting in the country, with the collaboration with Olympic Gold Quest (OGQ), the program will be **free of any course fee** for the selected participants. Lunch and other refreshments during the days of the course will be provided to the participants. However, they will have to make their own arrangements for boarding/lodging and transport.

12 participants in each discipline shall be selected as per the below mentioned selection guidelines. Apart from this, three participants in each discipline shall be selected by NRAI from upcoming states in shooting sport. Applicants from the North East Zone will be given first preference.



This Program is the first of its kind to be conducted by NRAI trainers. There will be a lot of focus on Practical sessions and sports science.

Only applicants, who fulfill the following conditions, shall be considered for the Course:

- 1. Candidates above the age of 21 years can only attend the Course.
- 2. Minimum educational qualification 12th board pass and must have basic knowledge of English.
- 3. The selection of participants for this course will be made based on the information provided by the applicants in the online application form
- 4. The criteria for selection include the following parameters:
 - ✓ Coaching experience & certification
 - ✓ Athlete performance in the last ten years along with Athlete Declaration
 - ✓ Performance by applicant during playing career
 - ✓ Applicants, who have attended the NRAI and ISSF National Coaches Course or NRAI and ISSF Judges/Jury and Referee Course will not be given preference.
- 5. The NRAI holds the right to approve/reject the application of any participant in the course.
- 6. Those who are desirous of attending the above course should submit the online application by Thursday, 28th March 2024.
