IMPORTANT INFORMATION

1. The aims and objects of this association are to encourage the art and science of marksmanship throughout the Republic of India particularly amongst the Civilian population as a healthy sport which will also serve the purpose of self-defense.
2. The administration and management of this Association is carried out by the Governing Body which can appoint various Sub- committees for the purpose.
3. The classes of Membership and fees are as follows:-
 - (a) **Life - Membership :-** One time membership amount of Rs. 35,000/- and Rs. 125/- of Membership Card. Plus 18% GST (Total comes to Rs. 41,448/-)
 - (b) **Annual Membership :-** Rs. 15,000/- as admission fee and Rs. 1000/- as yearly subscription.
(5 years subscription of Rs. 5000/- will be paid in advance at the time of enrolment and Rs. 125/- cost of Membership Card. Plus 18% GST (Total comes to Rs. 23,748/- initially)
 - (c) **50% Concession Fee :-** One time membership amount of Rs. 17,500/- and Rs. 125/- of Membership Card. Plus 18% GST (Total comes to Rs. 20,798/-)
- (c-i) The shooter who has taken part in the latest National Shooting Championship Competitions (NSCC) and has achieved the MQS as per NRAI Match Book may be enrolled as Life or Annual Members of NRAI under rule 3(f) &(j) of NRAI on 50% concession for Life Membership. The Annual Membership fee will remain the same.
- (c-ii) Relation of existing members- Mother, Father, Sons, Unmarried Daughters and spouse may be enrolled as Member of NRAI as defined under clause 3(f) & (j) of NRAI Rules & Regulations on 50% concessional Life Membership Fee. In the case of Annual Membership, the annual membership fee will remain the same. This concession will not be available in case the relation of an annual member intends to become Life Member. The existing member will submit an affidavit confirming his/her relation between the member and the applicant.

5. All Correspondence will be made in the name of the Secretary General, **National Rifle Association of India "NRAI HOUSE" 51-B, Tughlakabad Institutional Area, New Delhi - 110062.**
6. Please note that the membership proposal should be from a member of the Association and it should be seconded by another member of this Association.
7. The endorsement is necessary by any Member of Parliament/MLA, District Magistrate, a member of the Governing Body of **NRAI** or any **Gazetted Officer of the Government of India/ State Government.**
8. Annual fees will be sent to office address by 1st April each year in advance or any other date that may be fixed in future without awaiting reminders.
9. A member shall cease to be a member of NRAI as per Rules and Regulations of NRAI.
10. The Annual and Life membership will be subject Clause 3(f) of Rules and Regulations of NRAI.
11. Rule 3 (j) No person shall be eligible to become, or continue as a member in any category, if he/she and or his/her spouse is or becomes a dealer of arms and or ammunition. If a member or their spouse starts the business of arms and or ammunition at any stage after becoming member of NRAI, he/she or both, as the case may be, shall cease to be member of NRAI.....
12. The membership is also available to spouse, son and unmarried daughter on 50% concession within 5 years after his/her death of the member. This is valid only if membership is applied within five years from the date of death.
13. The minimum age limit for membership is 10 years.

If any declaration given by any member- at the time of becoming a member - is found to be false, such member shall cease to be member with immediate effect.
