

**AFFIDAVIT FORMAT FOR ISSUING FRESH IMPORT PERMIT**

**(ON RS. 50/-STAMP PAPER DULY ATTESTED BY NOTARY)**

The items (**Ammunition**) as stated above shall be used by me for Target practice only and National Rifle Association of India can always make physical check of the stock of live cartridges and empties.

**The Ammunition being imported by me is as per specifications of ISSF and is not a High Power or Magnum Ammunition**

I, hereby undertake that the empties of the ammunition imported under this import shall be deposited with National Rifle Association of India, immediately after its consumption.

That the weapon as stated above so imported will not be disposed off, sold or transferred to any persons/association without prior permission from NRAI.

Please note that the weapon will not be sold/transferred/gifted to any one for **two years** from the date of import. After the completion of **two years**, the weapon can be sold/transferred/gifted to **Upcoming/Aspiring/Renowned Shooter as per DGFT Norms**. The prior permission/clearance must be obtained from NRAI before transfer of weapon to the first buyer indicating the name, address and shooting credential and record/licence of the first buyer as Upcoming/Aspiring/Renowned Shooter. The first buyer will give an undertaking to NRAI about the details of the 2<sup>nd</sup> buyer, as stated above, at the time of sale of weapon, which can take place only after one year from the date of first purchase. **(This Paragraphs is for the shooter, who is importing Small Bore RIFLE/PISTOL & SHOTGUN ARMS)**

**OR**

That the weapon will not be sold/transferred/gifted to any one for **five years** from the date of import. After the completion of **five years**, the weapon can be sold/transferred/gifted to any Arm Licencee with prior permission/clearance from NRAI. **(This Paragraphs is for the shooter, who is importing BIG BORE RIFLE/.357 HANDGUN/12 BORE SEMI AUTOMATIC SHOTGUN)**
