SUB: Selection Trial 1 & 2 in Rifle/Pistol events under Group “B” at Dr. Karni Singh Shooting Ranges, Tughlakabad, New Delhi from 14th February to 4th March, 2025.

Dear Sir/Madam,

1. In accordance with the Selection Criteria 2025, it has been decided to hold Selection Trial No.1 & 2 under Group “B” in Senior, Junior & Youth Men and Women Rifle/Pistol events at **Dr. Karni Singh Shooting Ranges, New Delhi** as per the program attached as per Annexure “A”.

- i. THE MATCHES WILL START AT 8:00 A.M
- ii. DETAILS WILL BE PUT UP ON THE WEBSITE/MAIN NOTICE BOARD BEFORE THE START OF THE MATCHES.
- iii. THERE WILL BE NO FINALS DURING THESE TRIALS.
- iv. PROGRAM IS SUBJECT TO CHANGE AND CHANGES, IF ANY, WILL BE NOTIFIED AT THE VENUE.
- v THE MATCHES WILL BE CONDUCTED AS PER ISSF FORMATS/RULES.

2. Scores will be entered in main log sheet of “Group B” for calculating the average.

FOR DEAF SHOOTERS

- 3a) The Governing Body of NRAI in its meeting held on 6th March 2023 has approved MQS for participation by deaf shooters in Selection Trials (Group – B) with the condition that the score of Selection Trials will not be considered for Selection in International Competitions. **All deaf shooters will be allowed to use hearing aid in all matches conducted by NRAI unless mentioned otherwise.**

Participation in Deaf category is restricted to shooters who must be Deaf, defined as a hearing loss of at least 55 db PTA in the better ear (3-tone frequency average at 500, 1000 and 2000 Hertz, air conduction ISO 1969 Standard)

Verified deaf shooters who have participated in deaf or General category in the 67th NSCC and achieved MQS as below, are eligible to participate in the Group B trials.

Shooters wanting to participate in Deaf category for the first time have to email their Disability Certificate/Audiogram from Govt. Hospital to Technical Director/Coach, email ID anujajung@gmail.com, for verification by Coach and AISCD (All India Sport Council of the Deaf)

4) These trials will be organized and conducted by the NRAI. Shooters, who have achieved the scores as per Annexure“ C” of Selection Criteria 2025, during the following competitions, will be allowed to participate in these trials. The Selection Criteria is available on our website www.thenrai.in

- i. 67th NSCC Rifle/Pistol Events 2024-25
 - ii. Shooters based on average of four high scores, which is equal to MQS (as per “Annexure C”) shot by them during the year 2024 will be allowed to participate in Selection Trials
 - iii. Rajiv Gandhi Khel Ratna Awardee / Arjuna Awardee are exempted from MQS in the event category in which they have received award.
- 4) The tentative program is attached herewith. The time and details will be notified on our website www.thenrai.in after last date of filing entries (with Triple fee).
- a) Shooters will have to make their own arrangements for arms, boarding & lodging. Ammunition may be provided subject to availability with NRAI at Shooting Range against payment and on valid arms license.
 - b) A Junior shooter who is eligible to participate in Sport Pistol event can also participate in STD Pistol Junior Women Event.
 - c) **THE ENTRIES WILL ONLY BE ACCEPTED IN “NRAI’s ONLINE SYTEM” and no paper entry will be accepted. Shooters are required to visit our website www.thenrai.org to file their entries online. The online entries with normal fee will be accepted till 7.30 PM on 3rd February, 2025. Late entries with triple entry fee will be accepted online till 7.30 PM on 5th February, 2025.**
 - d) Group B Shooters will not be allowed to shoot in ANY match in Group “A” Trials.
 - e) **Details of entry fee are attached at Annexure“ B”**. Entry fee will not be refunded except in the event of the match being cancelled.
 - f) Shooters may send email to NRAI office for any assistance on email ID indiashooting@gmail.com
 - f) Shooters, who are completing the age, as stated below in 2025, will be allowed to participate under age categories matches:

Juniors – 21 years

Born in 2004 or above.

Youth – 19 years or below

Born in 2006 or above.

- g) **A Transit shooter, who is qualified to shoot Junior/Youth Trials by virtue of having shot the requisite MQS in the 67th NSCC would be eligible to shoot the Senior/Junior Selection Trials for the year 2025.**
- h) **ENTRIES SENT BY EMAIL ARE NOT ACCEPTABLE.**
- i) All shooters must attach a photocopy of their valid passport while filing online entry, if not done earlier. Please ignore, in case the copy of the passport, which is valid as on date of filing the entry, has already been uploaded on our system.
- j) Shooters are required to print their competitor cards and Equipment Control Form and bring the same with them at the time of participation, failing which Rs. 200/- (plus 18% GST = Rs.236/-) will be collected for each card/form, if supplied by NRAI.
- k) Shooters can print their cards/forms after 5th February, 2025.
- l) The Finals will not be conducted in any events.
- m) **No request for lane / detail adjustment will be accepted nor any request will be replied. Shooters are required to shoot their trials in allotted details only.**
- n) If the shooter has given the Entry and wish to withdraw, he/she has to inform to NRAI 48 hours before the commencement of his/her event, giving reasons for the same.
- o) Shooters are required to enter the range 90 minutes before the reporting time of their detail.
