## Sub: NRAI National EST Course

### Dear Sir/Madam,

It gives me great pleasure to share with you that the NRAI has a new Electronic Shooting Target (EST) Course to upskill and update the knowledge of the Indian Technical officials. It will be NRAI's own EST program which includes course design and material to address the developments in shooting sport and to equip our match officials with the correct tools.

The first course will be from 1<sup>st</sup> to 3<sup>rd</sup> February 2025 and the second course will be held from 8<sup>th</sup> to 10<sup>th</sup> February 2025 at Dr. Karni Singh Shooting Ranges, New Delhi under the aegis of the National Rifle Association of India.

As a commitment by NRAI towards promoting, the sport of shooting in the country, with the collaboration with OGQ, the program will be **free of any course fee** for the selected participants. Lunch and other refreshments during the days of the Course will be provided to the participants. However, they will have to make their own arrangements for boarding/lodging and transport.

Thirty participants in each course shall be selected, as mentioned in the selection guidelines.

Only applicants, who fulfill the following conditions, shall be considered for the Course:

- 1. Candidates must possess an **active ISSF/NRAI Judges license**.
- 2. Candidates above the age of 21 years can only attend the Course.
- 3. Minimum educational qualification Graduation and must have knowledge of English.
- 4. The selection of participants for this course will be made based on the information provided by the applicants in the online application form.

- 5. The criteria for selection include the following parameters:
  - ✓ **First preference** will be given to the participants who have an active ISSF license and serving as an official in NRAI tournaments.
  - ✓ <u>Second preference</u> will be given to the participants who have NRAI Judges license and serving as an official in NRAI tournaments.
  - ✓ <u>Third preference</u> will be given to those who have an who have an active ISSF Judges license or NRAI Judges license and willing to work in NRAI tournaments.
  - ✓ Applicants with only a background in Rifle & Pistol discipline will be considered.
  - ✓ Applicants willing to attend this course must complete five (5) mandatory internships as an official in NRAI-sanctioned tournaments and are required to fill out the undertaking as well

The NRAI holds the right to approve/reject the application of any participant in the course.

- 6. Those who are desirous of attending the above course should submit the online application by Wednesday, 15<sup>th</sup> January 2025 before 5:00 PM.
