### **THE SHOTGUN SHOWDOWN**

After organising multiple Air Rifle / Air Pistol events, Precision Shooting Club takes immense pleasure in announcing its **1<sup>st</sup> Shotgun Shooting Tournament** for Trap & Skeet event on **6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> September 2024** at **Dr. Karni Singh Shooting Range, Tughlakabad, New Delhi**. This is a part of the continuing efforts of the Club to promote and encourage shooting sports. This tournament is being organised under the guidance of Delhi State Rifle Association and its parent body National Rifle Association of India.

### **Competition is open to shooters from all states**

1. The **last date** for submission of entry is **01.09.2024** with a regular fee, after which a double fee will be charged.
2. Late/on-the-spot entries will be considered only if it is possible to accommodate such participants depending on the availability of spots.
3. Any outstation individual who achieves a qualification score in this tournament will not be eligible to represent Delhi in future events.
4. **Rupees 1 lakh in Prize Money\***.  
(\*Subject to terms and conditions)
5. The tournament will be conducted under the supervision of an observer nominated by the Delhi State Rifle Association.
6. The following documents and the requisite entry fee have to be submitted along with the entry form without which the entry form will not be accepted:
  - a. Two recent passport-size photographs.
  - b. Self-Attested copy of Shooter ID Card.

- c. Proof of identity along with proof of age: Self Attested copy of Voter ID/ Aadhar card/ Passport.
7. Shooters have to make arrangements for shooting equipment (gun, ammunition, etc).
8. Precision Shooting Club reserves the right to amend the rules at any time, at its sole discretion, for the smooth functioning of the event and any such decision made would be final and binding.
9. Entry on first come first served basis.

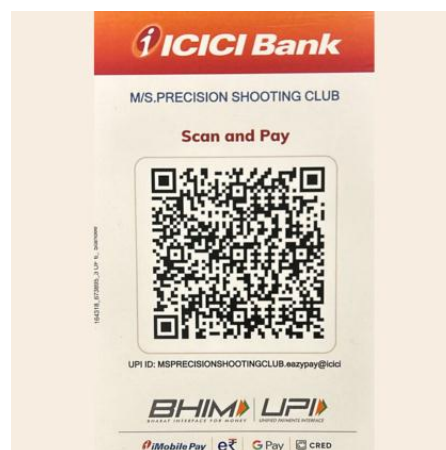

## GENERAL RULES:

- The minimum age for participation for firearms events is 12 years. Shooters below the age of 21 years as on 31-12-2024 (i.e. born on or after 01-01-2004) will be considered as Junior category. Shooters above the age of 45 years are eligible to participate in Masters category and shooter above the age of 60 years are eligible to participate in Senior Masters category.
- A Self-attested copy of NRAI Shooter I.D. / Municipal Birth Certificate must be submitted in case of Junior Shooters.
- No PET will be conducted.
- Each shooter will shoot 5 rounds totaling 125 points.
- Junior category shooters can participate in both the Junior and Senior categories.
- All participants should report at the venue by 8.00 AM sharp.
- **Cash prizes for in ISSF Men & ISSF Women categories. TOP 3 MEN & WOMEN will play a combined FINALS in TRAP & SKEET**
- **Cash prize for all categories.**
- In case of a tied score, count back method would be adopted to break the tie.
- The protest fee is Rs. 500/-. Protest timing - within 30 min. of declaration of result.
- Charges for correction of wrong entries is Rs. 200/-.
- The venue and timing of Prize Distribution ceremonies will be on the notice board. Certificates will be issued to all participating shooters.
- Submission of the filled Entry Form and Fee by a Shooter confirms acceptance of these Rules. The organizers reserve the rights for approving the entries.
- The organizers in the event of cancellation or delay of event reserve the rights for reorganizing the competition or rescheduling the competition. No refund shall be given in such cases.
- All competitors must declare if they are a domicile of Delhi or outside Delhi and which state did they represent in the years 2023 & 2024
