CIRCULAR

TECHNICAL RULES

1. ORGANISATION

- a) All India Sports Council of the Deaf (AISCD) will be organising the 3rd National Deaf Shooting Championship in accordance with ISSF Rules and NRAI Match Book 2024 (amended).

2. VENUE

- a) The 3rd National Deaf Shooting Championship will be held at Shooting Range, Phase-6, S.A.S Nagar (Mohali) Punjab State -160 055 from March 12 to 15, 2026.

3. SCHEDULE

- a) As per Annexure "A"

4. PARTICIPATION

- a) *Participation in the Championship is restricted to athletes who must be deaf, defined as a hearing loss of at least 55dB PTA in the better ear (3-tone frequency average at 500, 1000 and 2000 Hertz, air conduction ISO 1969 Standard).*
- b) *Open to eligible Deaf athletes who participated in the 67th or 68th NSCC in any category. Athletes who have not achieved MQS in the NSCC can also participate in the Deaf National Championship.*
- c) *It is mandatory for athletes to participate in the National Deaf Championship in order to be considered for selection to Deaf shooting Team for International Competitions conducted by ICSD and APDSC in the Year 2026-2027.*

5. CLASSIFICATION OF AGE GROUP

- a) There is no age category. All athletes will participate in the category of Men or Women.

6. CONDUCT OF EVENTS

- a) Events will be conducted as per ISSF Rules.
- b) All matches will be conducted on Meyton Electronic Target System.
- c) Athletes have to shoot matches without hearing aids.

- d) Hearing aids will not be allowed in the field of play.
- e) Players have to remove hearing aids before entering the field of play prior to start of matches & training.
- f) Finals will be conducted only in 10m events with minimum 08 (eight) participants.

8. SUBMISSION OF ENTRY FORMS

- a) Entries will be accepted through the "NRAI's ONLINE SYSTEM". Athletes are required to visit the website www.thenrai.org to file their entries along with online payment of entry fee. **Last date for accepting entries is 28th February 2026.**

9. WEAPON CARRY AUTHORITY LETTER

- a) Athletes travelling by air, can download Weapon Carry Authority Letter from website www.thenrai.org after submitting their entries. DGCA letter can be downloaded from <https://www.thenrai.in/PDF/a8a5c836-8c72-433a-b31b-42c56a41f271.pdf>

10. PROTEST AND APPEALS

- a) Any protests and appeals will be dealt as per ISSF Rules and NRAI Match Book 2024.
- b) The protest fee is Rs. 200.00 (Rupees two hundred only) and should be filed within 30 (thirty) minutes of completion of match and in case of Appeal to Jury of Appeal, the protest fee is Rs. 500.00 (Rupees five hundred only) to be filed within 1 (one) hour of completion of match.

11. WEAPONS AND AMMUNITION

- a) Athletes have to bring their own Equipment. No ammunition or Air Pellets will be available for purchase at the venue.
- b) Athletes must carry Equipment control card of last NSCC played.

12. GENERAL INSTRUCTIONS

- a) Participants are requested to go through above instructions carefully and ensure strict compliance.
- b) Scores achieved in this competition will be considered to qualify for group B trials, as per group B trial MQS.
- c) Participants are expected to follow rules of the competition strictly and maintain discipline on and off the field.

- d) Entry fees will not be refunded in case of non- participation after submission of entry.
- e) Shooting Kit (Equipment & Clothing) of competitors should be strictly as per ISSF rules.
- f) Shooting practice in place of Accommodation is strictly prohibited. In case of violation disciplinary action will be initiated and shooter may be barred from taking part in the competition.
- g) Accompanying persons/ personal coaches are not allowed to enter field of play.
- h) The organisers will have the right to close any match or event in case of any emergency or otherwise without assigning any reason for such an action on their part.
- i) The organising committee reserves the right to amend the rules at any time at its sole discretion for events/ circumstances beyond their control. Any decision made by the Organising Committee in any such matter will be final. All participants are expected to abide by the rules and regulations for the competitions.
- j) Athletes are advised to carry printout of their competitor card and UDID/ Disability certificate.

13. CODE OF CONDUCT

- a) Be a responsible human being and a committed sportsperson.
- b) Be respectful towards fellow athletes, officials and staff & follow directions of the officials.
- c) Be punctual.
- d) Dress appropriately as per dress code prescribed by ISSF.
- e) Shall not indulge in any kind of verbal abuse, or intimidation in form of shouting, making gesture, or any other form of distraction towards any spectator, official, players or coaches.
- f) Shall not indulge in any political or religious discourse /discussions.
- g) Shall not make any inappropriate or unwanted physical, verbal or sexual advance towards anyone.
- h) Shall not consume alcohol or tobacco in the competition premises.
- i) It is the responsibility of the shooter to be aware of all the rules and be responsible for their equipment being as per ISSF regulations
- j) Shooter is responsible for following all rules/ norms and go through the notices issued by AISCD/ NRAI.
- k) Adhere to WADA/ NADA rules and not use drugs which are not permitted under WADA/NADA.
- l) In case of any grievance contact the director of competitions as per details given below.
- m) Shall not interact with media in any form or over any print/ electronic/ social platform or post any material which is contrary to the spirit of IOC Charter, ISSF rules, shooting sport, fellow athletes, coaches other office bearers of AISCD or NRAI and against policies of the Government of India.

- n) Shall not bring shooting sport into disrepute through media that relate to tournament officials, technical officials, opposing coaches or team officials and or players that are personal in nature, imply bias or question their integrity.
- o) Violation of the above may lead to cancellation of entry of this championship.
- p) Athletes may contact the Director of Competition for any further information details that maybe required by them and might not have been covered by the above instructions.


14. FOOD & ACCOMMODATION

- a) All the athletes and accompanying Coach-cum-Managers (for the prescribed number only) shall be provided with free boarding & lodging during the Games.
- b) No observer or parents shall be allowed.
- c) All athletes and managers must bring their own bed sheet / blanket and personal items.
- d) The mess will open with the lunch on 12th March 2026 and will close with the Evening Tea on 15th March, 2026.
- e) Teams / Competitors (including accompanying officials) who have completed their match / event and have no more match / to compete in the Championship can leave the camp, if they desire so, with the permission of the Organising Secretary. List of such competitors must be submitted to the Organising Secretary by the Manager / Head of the concerned State team.

15. PRIZES & AWARDS

- a) Gold, Silver and Bronze Medals and Certificate of Merit will be presented to I, II and III place winners, respectively. In case of only 3 participants in an event, medals will be awarded to only 2 top scoring participants & in case of two participants in an event, medals will be awarded to only the top scoring participant.
- b) Certificate of Participation will be awarded to all participants by the Hosts.
