

AMENDMENTS IN SHOTGUN DOMESTIC, OLYMPIC GAMES 2024 CRATERIA AND NRAI MATCH BOOK 2023

1. The NRAI will be conducting common selection trials under Domestic Selection Criteria and OG Selection Criteria. Shooters achieving 110/125 (M) and 95/125 (W) in 66 NSCC will be eligible to participate in common selection trials under both domestic and OG Selection Criteria. However, scores of shooters, who fulfil the criteria, as defined under Clause 4 – Selection & Eligibility Criterion of OG, will be considered for selection of shooters for OG 2024.
2. **PARTICIPATION BY QUOTA HOLDERS (amended): The Quota holders will automatically be included in the main team of every World Cup and all other international competitions, if India has won maximum allowable quotas (two) in the relevant event prior to Olympic Games 2024.**
3. **New Clause 4.3.1 – All quota winners, irrespective of their ranking in Finals in Quota competitions, will be awarded one bonus point. It will be added to the points accumulated from the Olympic Games Selection Trials. This bonus point will be over and above the points, as stated under Clause 4.3 supra.**
4. 4.4 (amended) All shooters, including the Quota holders, will be required to shoot a minimum of 03 (three) selection Trials in the Olympic Selection Trials. Therefore, a shooter can choose to skip ONE of the FOUR selection trials as long as they can provide minimum three Event Points to be considered for selection into the Olympic team.
5. **4.4.1 Three high Event points out of 4 Olympic Selection Trials will be considered for Final Ranking. In case a shooter has only three Event points, then all three shall be considered for ranking. Final ranking for selection of shooters for 2024 Olympic Games will be based on following:**

Three Event points + Bonus Points under Clause 4.3 + Bonus point under Clause 4.3.1 = Final ranking
6. Mixed Team Events under Domestic and OG Selection Criteria (amended): The NRAI reserves the right for final composition of the team, **based on the performance of the shooter in that event during the competition and on the recommendations of the Chief Coach/Foreign Coach.**
7. Clause 4.7 of OG Selection Criteria (amended) – The Paris Olympic Team will be decided after the conclusion of the ISSF World Cup Lonato, Italy which is scheduled from 10-19 June 2024.
8. All previous scores/averages prior to start of 67 NSCC shall be annulled and shooters will start from Zero. The score of 67 NSCC shall be the first score for further selection of international teams for new Olympic cycle.
9. The amended Criteria are placed on the website of NRAI.
10. The Governing Body of NRAI reserves the right to modify/delete any section of both the Criteria.

AMENDMENTS UNDER NRAI MATCH BOOK 2023

MQS for para shooters under 17.6 of NRAI Match Book

Clause 10.3 is amended as under:

“Medals/Badges will not be awarded to those, whose score is less than the qualifying marks as prescribed for the relevant matches irrespective of their individual position. The grading of those securing above the qualifying marks will be done as usual.”

Clause 10.4 is amended as under:

- a) 3 prizes when there is a minimum of 4 shooters completed full course.
- b) 2 prizes when there is a minimum of 3 shooters completed full course.
- c) 1 prize when there is a minimum of 2 shooters completed full course.

The above rule will not apply in case of **Deaf**, Senior master’s and Super Masters categories.

Clause 1.1.5 of NRAI Match Book is amended as under:

A person, who has participated in an international competition, where an Indian team selected **as per ranking** by NRAI and sponsored by NRAI/SAI/Govt./**own cost**, will be an “international shooter” in respective category (senior/junior, youth, **Masters, Senior Masters, Super Masters, Deaf**). **This is subject to achieving MQS equal or above the MQS fixed for selection trials, by a shooter in international competition.**

Clause 1.4 of NRAI Match Book is amended as under:

1.4 A Shooter is eligible to participate in AIGVMSC/ZONAL CHAMPIONSHIP/or any other competition recognized by NRAI only if he/she has achieved the following minimum qualifying score in the previous AIGVMSC, Zonal Championships, All KSS Inter School Shooting Championship (air weapon events only), Inter University, Inter College Competitions (conducted under the supervision of NRAI), in State Championship (Full course as per NRAI Match Book) conducted by the State or any other competition approved by the Governing Body of NRAI in those events in which he/she wishes to participate. Scores of such competitions must be filled at the time of sending entries for AIGVMSC/Zonal Championship/or any such state level competition conducted by the State (where the State announces the competition in their annual calendar and scores appear on the website of the State Association immediately on completion of the competition) or any other competition approved by the Governing Body of NRAI in those events in which he/she wishes to participate. Scores of such competitions must be filled at the time of sending entries for

AIGVMSC/Zonal Championship/or any other competition recognized by NRAI. Scores of special selection trials, conducted by affiliated units, for the shooters, who failed to achieve MQS in said competitions, shall not be considered. **In case shooter is not qualified in a particular event and adds his/her entry that event on the portal of NRAI, a penalty of Rs. 5000/- (plus GST, as applicable) shall be imposed on the shooter. The shooter will be allowed to participate in the competition only after payment of penalty amount.**

Clause 17.10 of NRAI Match Book is amended as under:

In case shooter is not qualified in a particular event and adds his/her entry that event on the portal of NRAI, a penalty of Rs. 5000/- (plus GST, as applicable) shall be imposed on the shooter. The shooter will be allowed to participate in the competition only after payment of penalty amount.
