Subject: Notice of Elections for the Term 2025–2029, Request to the Affiliated Units for Nomination of Representatives for General Body for the term 2025-2029 and forwarding the MOPG issued by the Returning Officer

Dear Sir/Madam,

The term of the present Governing Body of National Rifle Association of India (NRAI), was till 18th September 2025.

The Governing Body of NRAI in its meeting dated 2nd August 2025 had authorized the President NRAI to appoint a Returning Officer to conduct the elections of Governing Body of NRAI for the term 2025-2029. Accordingly, Hon'ble Justice Ms. Nirmaljit Kaur (Retd.) was appointed as the Returning Officer to conduct the aforesaid elections, which was approved by Governing Body of NRAI on 9th August 2025.

However, the elections got deferred for a period of three months vide decision of the Indian Olympic Association (IOA) and Ministry of Youth Affairs and Sports (MYAS).

Thereafter, now in accordance with the decision of the Governing Body to hold the elections within the extended period, the President has fixed the date and venue of the General Body Meeting on **4th December 2025 at 11:00 AM onwards at Hotel Park Plaza, Ambala Chandigarh National Highway, Zirakpur, District Mohali, Punjab.**

All affiliated State/UT Associations are requested to nominate two representatives as members of the General Body of NRAI for the term 2025–2029, in accordance with the Rules and Regulations of the NRAI Constitution. It is requested that at least one nominee should be a prominent sportsperson. Only these two nominated representatives will be permitted to attend the General Body Meeting on 4th December 2025.

Please note that incomplete nominations will not be entertained.

In case of different names forwarded for nominations from the President and Secretary General of a State/UT Association, only the names submitted by the President will be accepted as per the NRAI Constitution.

Kindly also note that under Rule 9(c) of the Constitution of NRAI, no affiliated State/UT Association is eligible to contest or vote in the NRAI elections if it has not held its own elections within the past four (4) years, as of 2nd November 2025.

All nominations must reach the NRAI office by 12:00 noon on 18th November 2025 via email at indiashooting@gmail.com with complete information and documents as stated above. The nominations must also be sent by Registered Post to NRAI on the official letterhead of the unit, duly signed by its President or Secretary General. In case the nominated names forwarded, differ in the email and letter, the nomination of the representatives will suffer rejection.

Any change in the name of an authorized representative after 18th November 2025 shall be permitted only with the approval of the President, NRAI, and must reach the NRAI office before 12:00 noon on 19th November 2025.

The MOPG (Memorandum of Procedure and Guidelines) issued by the Returning Officer are enclosed and are also being posted on the NRAI website: www.thenrai.in.

Nominated members be requested to make it convenient to attend the meeting on 4th December 2025 at the venue stated above.
