**Sub: NRAI National Judges Course (Rifle & Pistol)**

Dear Sir/Madam,

The NRAI will be conducting a new NRAI National Judges Course (Rifle & Pistol) to increase the capacity of match officials. Developed in-house, the program addresses recent developments in shooting sport and provides officials with the practical tools required for accurate, consistent, and confident officiating.

The program will be from **23<sup>rd</sup> to 27<sup>th</sup> February 2026 at Dr. Karni Singh Shooting Ranges, New Delhi** under the aegis of the National Rifle Association of India.


As a commitment by NRAI towards promoting the sport of shooting in the country, with the collaboration with OGQ, the program will be **free of any course fee** for the selected participants. Lunch and other refreshments during the days of the Course will be provided to the participants. However, they will have to make their own arrangements for boarding/lodging and transport.

A total of 30 participants shall be selected, as mentioned in the selection guidelines as mentioned below:

Applicants who fulfill the following criteria shall only be considered for the Course:

1. Candidates above the age of 25 years can only attend the Course.
2. Minimum educational qualification – Senior Secondary(12<sup>th</sup>) and Mandatory to have knowledge of English -Spoken and Written.
3. The selection of participants for this course will be made based on the information provided by the applicants in the online application form.



4. The criteria for selection include the following parameters:
  - ✓ Previous National, State and Regional Match official work experience & certification (Duly signed and stamped declaration Form) /Letter issued from State Association/ Unit
  - ✓ Performance of applicant as a shooter (only performance of NSCC/International Competition will be considered)
  - ✓ Applicants with only a background in Rifle & Pistol discipline will be considered.
  - ✓ Applicants willing to attend this course must complete 60 days of mandatory internships as an official in NRAI-sanctioned tournaments and are required to fill out the undertaking as well.
5. The NRAI holds the right to approve/reject the application of any participant in the course.
6. Those who are desirous of attending the above course should submit the online application by **Tuesday, 10<sup>th</sup> February 2026 before 5:00 PM.**
