Dear Sir/Madam,

The National Rifle Association of India (NRAI), in association with the International Shooting Sport Federation (ISSF) and in collaboration with Olympic Gold Quest (OGQ), presents the ISSF B Judges Course (Rifle & Pistol) a structured professional development programme designed to elevate Indian Technical Officials in line with evolving international officiating standards under NRAI Education Program.

The course will be held from 28th March to 1st April 2026 at **Dr. Karni Singh shooting Range in New Delhi, India under the aegis of the National Rifle Association of India**. The instructors nominated by ISSF to conduct this course are Mr. Paul Gumn (GBR), and Mr. Wataru Fujii (JPN).

The program will have a course fee of **Rs. 25,000/-** for the selected participants. This fee will be fully refunded upon the successful completion of the 60 days of mandatory internships. Participants will have to make their own arrangements for boarding/lodging and transport. The lunch and other refreshments during the days of the Course will be provided to the participants free of cost

30 participants in total shall be selected as mentioned in selection guidelines.

Applicants, who fulfill the following conditions, shall only be considered for the Course:

1. Candidates above the age of 25 years can only attend the Course.
2. Minimum educational qualification – Senior Secondary(12th) and Mandatory to have knowledge of English -Verbal and Written.
3. The selection of participants for this course will be made based on the information provided by the applicants in the online application form



4. The criteria for selection include the following parameters:

- **First preference** will be given to officials currently working with the NRAI who do not hold an ISSF License.
- **Second preference** will be given to applicants who have successfully completed the NRAI National Judges Course in both Rifle and Pistol disciplines.
- **Third preference** will be given to applicants who previously held ISSF Judges License but failed to renew it.
- **Fourth preference** will be given to applicants who have passed the NRAI National Judges Course in either Rifle or Pistol discipline.
- Applicants with only a background in Rifle & Pistol discipline will be considered.
- Applicants willing to attend this course must complete 60 days of mandatory internships as an official in NRAI-sanctioned tournaments and are required to fill out the undertaking as well.

The NRAI holds the right to approve/reject the application of any participant for the course.

5. Those who are desirous of attending the above course should submit the online application by **Friday, 6th March 2026 before 5.00 PM.**
