Agenda 7

Finalisation of cut-off age & criteria for Athletes to participate in KIYG 2025

An athlete **born on or after 1st January 2007 (U-18 Age)** is eligible to participate in Khelo India Youth Games 2025.

Qualification Criteria

Individual Sports

An athlete shall qualify for participation in Khelo India Games on the basis of his/her performance in the recent National Championships/Rankings of the respective sport organized by the respective NSF/SGFI/CBSE as the case may be.

The qualification shall be subject to the athlete cut-off age criteria and the number of quota places allocated to **NSF/SGFI/CBSE** in each event.









Team Sports

A total number of **8 teams** will participate in KIYG 2025. The top **7 states** will be nominated on the basis of their performance in the recent National Championships of the respective sport organized by NSF/SGFI as the case may be as per the allocated quota. The 8th team will be of the Host State

Representation

Individual Sports

The athlete shall represent the State/UT as per the details provided by NSF/SGFI/CBSE, depending on the allocated quota.

Team Sports

The team shall be selected by a committee constituted by the respective State/UT for each sport. The committee structure shall be as follows:

i. Representative from State Sports Department

: Chairman

ii. Representative from respective State Sports Association : First Member

iii. Representative from SGFI

: Second Member

iv. Any one of the following

: Third Member

(Dronacharya Awardee/ Arjuna Awardee/ Eminent Coach/Athlete of the respective sport)

Note: In case of Sports for which the NSF is not recognised by MYAS, the Steering Committee will be constituted excluding members from the respective State Sports Association.

Agenda 8

Finalisation of the Athletes' Nomination Policy

A. Registration and Nomination:

Individual Sports

The registration and nomination of athletes is to be done by the respective stakeholder namely **NSF/SGFI/CBSE** as per the allocated quota, on the basis of performance in the qualifying tournament/ ranking.

Individual Sports (Host State Quota/ Wild Card Quota)

The registration and nomination of athletes are to be done by the respective State/UT as per the allocated quota and criteria of Host State Quota/ Wild Card Quota.

Team Sports

The registration and nomination of athletes are to be done by the respective State/UT as per the allocated slot based on merit in each sport.

The following timeline should be strictly followed for smooth conduct of the Games:









Stage	Timeline
	Date of commencement of Games
Completion of Athlete Registration	T – 45 or within two (02) days of completion of qualifying tournament whichever is later
Completion of Nomination	T – 35 or within four (04) days of completion of qualifying tournament whichever is later
Replacement Deadline	T – 25 or within six (06) days of completion of qualifying tournament whichever is later

B. Replacement

Any athlete replacement requests submitted within the stipulated timeline as mentioned above shall be governed by the following policy:

Individual Sports/Events

- Replacement to be permitted only on the basis of merit i.e., performance in the qualifying tournament/ rankings and not restricted to the State/UT whose athlete is being replaced.
- Replacement is to be permitted only from the merit list of qualifying tournament/ rankings of the respective stakeholder.

The above shall be approved by the Games Technical Conduct Committee.

Team Sports/Events

- The replacement of athletes is allowed as per the timeline stated above.
- Athletes can be replaced only from the long list.
- The long list to be submitted by each State/UT, of Athletes who it deems potentially eligible and capable of being nominated for the Games.
- Prior registration on the NSRS portal shall be mandatory.

C. Vacant Slot

Individual Sports/Events

- In case the respective merit list from **NSF/SGFI/CBSE** is exhausted, the vacant slot may be allotted to the Host State on a merit basis.
- Nominations on account of the vacant slot to be completed by the Host State within two (02) working days of being intimated about the nomination.

Team Sports/Events

No re-allocation of vacant slot shall be done.









D. Late Athlete Replacement Policy

Any athlete replacement requests submitted after the stipulated timeline as mentioned in **point no. A** shall fall in the category of "Late Athlete Replacement" and shall be governed by the following policy:

Requests to be considered only on the following grounds on production of required documents:

- I. Selection in any International/ National competitions/camps Letter issued by the concerned NSF.
- II. Violation of Anti-Doping policy, appeals Letter issued by the National Anti-Doping Agency (NADA).
- III. Medical emergencies and on a case-by-case basis Medical certificate/ report from Government Hospital signed by Chief Medical Officer.

Decision on the Last date to submit the nomination

Timely Nomination of Athletes plays an important role in making necessary arrangements for the Games such as Sports Kits, Boarding and lodging, printing of Certificates, Accreditation, Travel Arrangements etc. Since, the Games are commencing on **5th May 2025**, it was decided to complete the nomination of Athletes by **10th March 2025**.

Agenda 11

Allocation of Wild Card quota to States/UTs

With an objective of promoting inclusion and providing adequate representation to States/UTs, the Khelo India Games have a provision for allocating 'Wild Card Quota' to States/UTs on the basis of participation in the previous edition. The following are the terms:

- A. State/UT with less than or equal to **50** (fifty) participating athletes in the previous edition of the Games shall be considered for participation under the wild card quota.
- B. The list of participants representing the eligible States/UTs shall be drawn on the basis of performances in the International/ National/ State/ District level tournaments (held in 2022/ 2023/ 2024).
- C. Priority in participation will be accorded to the State/UT with the lesser number of participations in the previous edition of the Games.
- D. No State/UT shall be allotted more than one slot under the wild card quota
- E. In case an eligible State/UT has representation on merit in the particular event, the State/UT shall not be allotted a slot under the wild card quota.
- F. A Wild Card Evaluation Committee shall be constituted to evaluate the wild card entries and finalise the participants.

Agenda 12

Allocation of Host State Quota

The Host State of the Khelo India Games is allocated quota places to ensure representation of the State wherein the Games are being hosted. The norms for allocation of Host State quota are mentioned as under:

- A) The Host State shall nominate the athletes against the quota on the basis of performance in the National Championship.
- B) **Individual Sports:** The Host State quota shall remain with the Host State in case of representation of the State in the particular event on account of merit.
- C) **Team Sports:** The Host State quota shall be allocated only if there is no existing representation of the State in the particular event on account of merit. In case the Host State has qualified on merit, the quota shall be re-allocated to the stakeholder (NSF or SGFI), based on whose quota the Host State qualified on merit.







D) In case of Sports wherein the NSF has been allocated additional quota due to non-identification of the 3rd place team as per the format of the qualifying tournament,

in such case if the Host State has qualified on merit through any of the stakeholders, then the Host State quota shall not be re-allocated. (e.g. Fencing Team, Football, Kabaddi, Kho-Kho)

The technical handbook acts as the guiding document for the conduct of the Games. The requisite details including but not limited to participation, events, FOP, competition format, rules and regulations, to be submitted by the NSF representatives before **1st March 2025** positively.
