Sub: ISSF Electronic Scoring Targets (EST) Course New Delhi India 2025

Dear Sir/Madam,

It gives me great pleasure to share with you that with the partnership of ISSF and in collaboration with OGQ, the NRAI will be conducting two ISSF Electronic Scoring Targets (EST) Course to up-skill and update the knowledge of Indian Technical Officials.

The First course will held from **24th to 28th February 2025** and second course will held from **05th to 9th March 2025** at Dr. Karni Singh shooting Range in New Delhi, India under the aegis of the National Rifle Association of India. The instructors nominated by ISSF to conduct this course are Mrs Jadranka Strukic (CRO), Mr. Khaled Aljraied (KUW) and Mr. Pawankumar Singh (IND).

The program will have a course fee of **Rs. 25,000/-** for the selected participants. Course fee includes the ISSF EST Course registration. This fee will be refunded upon the successful completion of the five mandatory internships after deduction of ISSF Registrion Fee. Participants will have to make their own arrangements for boarding/lodging and transport. The lunch and other refreshments during the days of the Course will be provided to the participants free of cost.

30 participants in each course in total shall be selected as mentioned in selection guidelines.

Applicants, who fulfill the following conditions, shall only be considered for the Course:

1. Candidate must hold an active **ISSF Judges Licnese**.
2. Minimum educational qualification – Graduation and Mandatory to have knowledge of English - Verbal and Written.
3. The selection of participants for this course will be made based on the information provided by the applicants in the online application form



4. The criteria for selection include the following parameters:
- **First Preference** will be given to applicants who have attended and passed the NRAI National EST Course.
 - **Second Preference** will be extended to those who currently serve as officials with NRAI.
 - **Third Preference** will be given to applicants who have attended the NRAI National EST Course.
 - Applicants with background in Rifle & Pistol discipline will only be selected.
 - Applicants willing to attend this course must complete five (5) mandatory internships as an official in NRAI-sanctioned tournaments and are required to fill out the undertaking as well. Officials currently working with NRAI are exempt from this requirement.

The NRAI holds the right to approve/reject the application of any participant for the course.

5. Those who are desirous of attending the above course should submit the online application by **Wednesday, 12th February 2025 before 5.00 PM.**
